## EVENT SUMMARY

On Tuesday, April 29, 2025, Clinton County, Ohio was placed under an Enhanced Risk (Level 3 of 5) for severe weather by the Storm Prediction Center, prompting Clinton County EMA to initiate Enhanced Monitoring. The forecast called for organized lines of storms capable of producing damaging straight-line winds, large hail, frequent lightning, and a low-probability risk of isolated tornadoes. Severe Thunderstorm Watch #188 was issued at 12:29 PM, followed by a series of Severe Thunderstorm Warnings beginning around 1:33 PM as the first wave of storms entered the area. A second watch—Severe Thunderstorm Watch #192—was issued at 4:51 PM and initially set to remain in effect until midnight, though it was cancelled by the National Weather Service at 8:05 PM as conditions improved. Clinton County experienced multiple rounds of storms throughout the afternoon and evening, with a peak wind gust of 48 mph recorded at the NWS Wilmington office. Despite the widespread storm activity, no tornadoes, injuries, or significant damage were reported. Nine AES power outages were noted by 8:22 PM, and no emergency declarations or EOC activation were required. EMA operations focused on monitoring conditions, coordinating with NWS and regional partners, and pushing timely public messaging through the county website and social media platforms. Residents were advised to remain weather-aware, secure outdoor items, and review shelter plans. Public communications emphasized hazard awareness using [cc-ema.org/prepare](https://cc-ema.org/prepare) keywords SEVERE, POWER, and TORNADO. Overall, the county avoided significant impacts due to timely information sharing, ongoing situational awareness, and the public's preparedness.

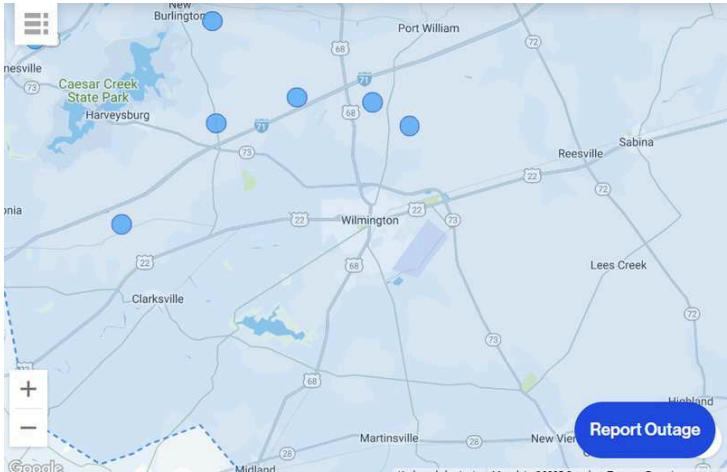

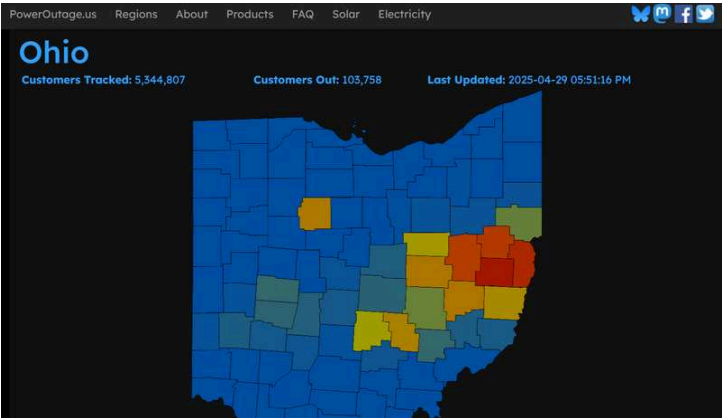
